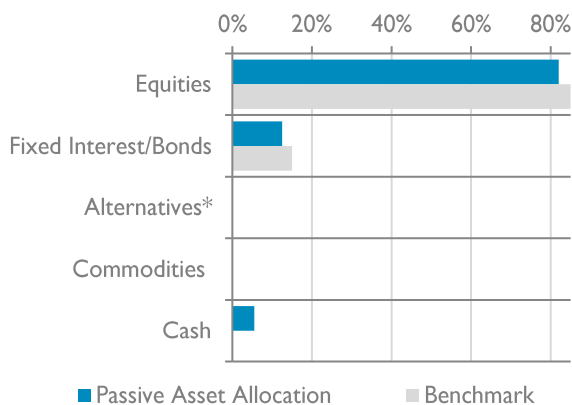

OBJECTIVE

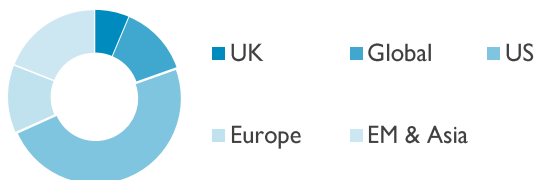
